### Sprague announces a cash distribution of \$0.4338 per unit

PORTSMOUTH, N.H., April 25, 2022 (GLOBE NEWSWIRE) -- Sprague Resources LP ("Sprague") (NYSE: SRLP) announced today that the Board of Directors of its general partner, Sprague Resources GP LLC (the "General Partner"), declared a cash distribution of \$0.4338 per unit (\$1.73 per unit on an annualized basis) for the quarter ended March 31, 2022, and is equal to the previous quarter's distribution.

The announced distribution will be paid on Wednesday, May 11, 2022, to unitholders of record as of the close of business on May 6, 2022.
